(2) THA-HIN Multi-State Data Exchange Selection

Years available for subscription: 2020-2025

Summary of this dataset:

THA contracts with the Hospital Industry Data Institute (HIDI) as our vendor to collect and process quarterly discharge data for Tennessee hospitals. HIDI also operates a Multi-State Data Exchange program (formerly known as Non-Resident Data Exchange) among their customers and other state data programs that elect to participate in this exchange. Currently, inpatient (IP), emergency department (ED) and ambulatory surgery (Am/Surg) data are available through this Exchange. Via THA's participation in this program, we receive summary discharge records from each participating state whose hospitals treat a Tennessee resident with IP, ED or Am/Surg services. Likewise, THA is sharing with other states, IP, ED and Am/Surg summary records for

patients from other states that were treated in a Tennessee hospital. This data can be used to enhance your hospital's market analysis reports by quantifying the number of patients that leave our state (or your service areas) and receive care in other states.

Participating states:

There are currently nineteen (19) states that are participating in the IP exchange, and nine (9) states participating in the OP exchange. Of the eight (8) states that border Tennessee, six (6) currently participate in the IP program, and three (3) in the ED program. NOTE: The number of participating states is subject to change with each data deliverable.

THA HIN has made the Multi-State Data Exchange database available for subscription to THA HIN member hospitals. Data uses for this dataset is limited to research, public health and operations. To subscribe to this dataset, please indicate below the year(s) you are requesting. Currently, THA HIN has 2020-2024 datasets available. 2025 will be available as described in the Data Delivery Schedule, or as received from HIDI.

The cost of subscribing to this dataset is **\$300 per year requested** and is delivered securely in a tab-delimited text file on a quarterly schedule.

(3) Kentucky Statewide Inpatient Data

If a consultant, third party vendor or other agent will have access to the data, a Confidentiality Agreement must be completed <u>prior</u> to receiving the data. NOTE: The Kentucky statewide inpatient database is an <u>annual</u> <u>subscription with delivery once per year</u>. Delivery of these data occurs in August or September, once they are made available to THA by KHA.
